Job Title: Professional Development Specialist (PDS)

ESSENTIAL DUTIES AND RESPONSIBILITIES:

Work under the direction of and in collaboration with the Early Childhood Professional Development Manager to support the recruitment and retention of family, group and center based child care providers in Flathead, Lake, Lincoln and Sanders counties.

• Recruitment of New Child Care Providers

- Provide technical assistance to individuals seeking registration/licensing. Meet individually with potential providers as needed.
- o Monitor distribution of registration packets and referrals to new child care providers.
- o Coordinate and participate in delivery of PME & ECE classes as specified in R&R Contract
- Become certified and teach 1st Aid CPR to child care providers within the region as needed

Retention of Child Care Providers

- Provide information, resources and technical assistance to current providers via phone, email, and face to face contact in support of their day to day program needs
- o Develop and maintain supportive relationships with providers throughout R&R region

Professional Development of Child Care Providers

- Assist in delivery of professional development in a variety of formats for family, group, and center based child care providers throughout the region
- Assist in process of approval, registration, and recording of provider classes as required through Montana Early Childhood Project
- Assist in creating, updating and dispersing quarterly PD calendar & newsletter as needed
- o Promote appropriate business practices of child care through trainings & on-site visits with providers.

• Program Support

- o Act as CDA Advisor and provide support for child care providers seeking their CDA credential as needed
- Provide support and mentoring for family, group and center providers pursuing accreditation
- O Deliver Technical Assistance (TA) to individual child care programs

• Public Relations

- Support Nurturing Center's public awareness activities in coordination with other program and agency activities...
- Coordinate and collaborate as requested with area agencies and organizations such as QAD, BBCC, FVCC, SKC, FAEYC
